Eighth copper-gold concentrate shipment departs port

Perth, Australia: Alara Resources Limited (ASX: AUQ – **Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce that the eighth shipment of copper-gold concentrate from its recently completed Wash-hi Majaza mine and processing plant has left Sohar Port for China.

Key Highlights

- Eighth shipment of 1263 WMT of copper-gold concentrate shipped, comprising approximately 194 MT copper and 6 Kg gold
- Reduced shipping cycle of under 2 weeks

Eighth Copper-Gold concentrate shipment leaves port

The Al Wash-hi Majaza copper-concentrator plant has achieved production of 1263.5 WMT of coppergold concentrate with approximately 194 MT of contained copper and 6 Kg of contained gold. This comprises the eighth parcel of copper-gold concentrate shipped from Sohar Port.

The table below compares the latest to the two previous shipments. This is the largest shipment dispatched from the Wash-hi plant to date. As demonstrated in the table, the copper concentrate grade is improving with each shipment.
