# Seventh copper-gold concentrate shipment ready to leave port

**Perth, Australia:** Alara Resources Limited (ASX: AUQ), a base and precious metals producer and explorer with projects in Oman, is pleased to announce that the seventh shipment of copper-gold concentrate from its recently completed Wash-hi Majaza mine and processing plant has been delivered to Sohar Port and is due to depart for China tomorrow.

 Seventh shipment of 1256 WMT of copper-gold concentrate to be shipped on November 13th, comprising approximately 188 MT copper and 5.158 Kg gold

### Seventh Copper-Gold concentrate shipment due to leave port

The Al Wash-hi Majaza copper-concentrator plant has achieved production of approximately 1256 wet metric tonnes (**WMT**) of copper-gold concentrate, containing approximately 188 metric tonnes (**MT**) of copper metal and 5.2 kg gold. This comprises the seventh parcel of copper-gold concentrate produced from the Wash-hi Majaza plant. The shipment is scheduled to depart from Sohar Port on 13 November 2024.

The recently improved 2-week shipping cycle has been maintained since the sixth shipment, as projected. Previous shipping cycles had been 3 to 4 weeks in length. The shortened production time for a shipment resulted from works to improve the performance of the tailings filter press (**TFP**) conducted during a shutdown in September. Considerable further improvements to the performance of the plant are expected from the TFP replacement program, as previously announced. The interim replacement TFPs are expected to be delivered, installed and operational by early in the new calendar year.
