25th Copper Concentrate Shipments Dispatched; Clarification on Dispatch Schedule

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 25th shipment of copper concentrate from its Al Wash-hi – Majaza copper-gold mine in Oman. The Al Wash-hi – Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

25th Dispatch Summary

- **25th shipment of 1003.7 WMT copper-concentrate shipped on 30th September, comprising 189.9 MT copper and 1.4 Kg gold**

The Al Wash-hi Majaza copper-concentrate plant has achieved a production of 1003.7 WMT of copper-gold concentrate with approximately 189.9 MT of contained copper and approximately 1.4 kg of gold in its latest shipping cycle. This comprises the 25th parcel of copper-concentrate exported from the plant, and departed Sohar Port on 30th September.

Production & Dispatch Cycles Clarified

Production and dispatch cycles at the Al Wash-hi Majaza plant are determined as per Trafigura's commitments, as well as vessel availability and Bill of Lading restrictions at the receiving port.

For the 23rd and 24th shipments of copper concentrate, the total requirement from Trafigura was for 3000 MT of copper concentrate to be shipped to China. The receiving port in China restricts the number of containers permitted in a single shipment. Therefore, the total quantity was dispatched in two shipments of 1500 MT each. While production cut-off was 14th September, the 23rd and 24th shipments were dispatched on 23rd and 21st September respectively as per the vessel schedule.

The 25th and 26th shipments of copper concentrate are to be dispatched to India as per Trafigura's instructions to Al Wash-hi Majaza. The 25th shipment of 1000 MT was dispatched on 30th September, and the next shipment is now under process.
