23rd and 24th Copper Concentrate Shipments Dispatched

Perth, Australia: Alara Resources Limited (ASX: AUQ) (Alara or the Company), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 23rd and 24th shipments of copper concentrate from its Al Wash-hi – Majaza copper-gold mine in Oman. The Al Wash-hi – Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (AHRL). Alara holds a 51% interest in AHRL.

Summary

23rd and 24th shipments of a combined 3006 WMT copper-concentrate shipped on 21st and 23rd September respiectively, together comprising 542.3 MT copper and 4.6 Kg gold

The Al Wash-hi Majaza copper-concentrate plant has achieved a combined production of 3006 WMT of copper-gold concentrate with approximately 542.3 MT of contained copper and approximately 4.6 kg of gold in its latest shipping cycle. These together comprise the 23rd and 24th parcels of copper-concentrate exported from the plant, and departed Sohar Port on 21st and 23rd September respectively.

The total quantity was dispatched in two separate shipments due to restrictions on the number of containers / Bill of Lading permitted at the receiving port. Additionally, the shipments were dispatched within a few days of each other, as per vessel availability.
